ORDINANCE

AN ORDINANCE TO AMEND THE 2023 POLICE BUDGET FOR PERSONAL SERVICES

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 Police budget for a salary adjustment to the Crime Analysis Center Officer in Charge in the amount of \$13,191.79 annually; and

WHEREAS, the funds are available from a DCJS Grant, and

WHEREAS, the salary adjustment is needed to be in compliance with the DCJS Grant requirements: and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on July 26, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 Police budget for salary adjustments from July 1, 2023 to December 31, 2023 as follows:
 - (i) \$ 6,595.90 increase expense budget line A3120.51000 (Per.Serv.– Police Capt.)
 - (ii) \$60,904.10 increase expense budget line A3120.51000 (Personal Services)
 - (iii) \$67,500.00 increase revenue budget line A.43389 (State Aid-Other Pub.Safety)

Section 2. That this Ordinance shall take effect immediately.
