**AN ORDINANCE TO ALLOCATE AMERICAN
RESCUE PLAN ACT FUNDS FOR THE DESIGN
OF THE HENRY STREET RECONSTRUCTION
PROJECT**

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to allocate American Rescue Plan Act (ARPA) funds in the amount of \$605,792 for the design of the Henry Street reconstruction project; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on August 9, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to allocate ARPA funds in the amount of \$605,792 for the design of the Henry Street reconstruction project as follows:

Transfer From (Decrease):

\$605,792 H8320.525105.F0015 (Wtr.Pl.Impr.)

Transfer To (Increase):

\$605,792 H5110.XXXXXX.F0015 (Henry
St.Storm Water Recon.)

Section 2. That this Ordinance shall take effect immediately.
