**A RESOLUTION AUTHORIZING THE CITY OF  
BINGHAMTON TO APPLY FOR A WIIA GRANT  
FOR UPGRADES TO THE WATER FILTRATION  
PLANT**

WHEREAS, the City of Binghamton is eligible to receive a Water Infrastructure and Improvement Act (WIIA) Grant for clean and drinking water projects from the New York State Environmental Facilities Corporation ("EFC") for upgrades to the Water Filtration Plant in the amount of \$3,000,000; and

WHEREAS, said grant, awarded and administered by EFC, will require the City to provide a local match of no less than 40% of the awarded grant by Bond.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office Corporation Counsel, as may be necessary to apply for a WIIA Drinking Water Grant from the EFC in the amount of \$3,000,000 for the Water Filtration Plant upgrades.
