A RESOLUTION TO ACCEPT THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES BODY WORN CAMERA FUNDING OPPORTUNITY GRANT

WHEREAS, the City of Binghamton is eligible to receive a Body Worn Camera Funding Opportunity Grant in the amount of \$70,000 from the New York State Division of Criminal Justice Services (DCJS); and

WHEREAS, the grant will be used to supplement and build on the current Body Worn Camera Systems; and

WHEREAS, there is no required City match; the grant funds will be upfront, and the Grant will be administered by the Officer in Charge of the Southern Tier Crime Analysis Center in the Binghamton Police Department; and the anticipated date of completion is June 30, 2024.
