AN ORDINANCE TO AMEND THE 2023 BINGHAMTON-JOHNSON CITY JOINT SEWAGE TREATMENT FACILITY BUDGET FOR STATE AND FEDERAL EMERGENCY DISASTER ASSISTANCE

WHEREAS, the City of Binghamton (the "City") is a joint owner of the Binghamton-Johnson City Joint Sewage Treatment Facilities (the "BJCJSTF") with the Village of Johnson City (the "Village"); and

WHEREAS, the BJCJSTF is operated and maintained by the Binghamton-Johnson City Joint Sewage Board (the "JSB") under a series of inter-municipal agreements between the City and the Village; and

WHEREAS, the Council of the City and the Board of Trustees of the Village approve the BJCJSTF budget; and

WHEREAS, the JSB has requested an amendment to the 2023 BJCJSTF budget to (i) increase the State Aid – Emergency Disaster Fund and the Federal Aid – Emergency Disaster Fund, and (ii) increase appropriations for Reimburse Owner Recovery Expense and Professional Services to reflect the FEMA NYS-DHSES check.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That Council approves and directs the Comptroller/JSB Fiscal Officer to amend and make journal budget entries in the 2023 BJCJSTF budget to (i) increase the State Aid – Emergency Disaster Fund and the Federal Aid – Emergency Disaster Fund, and (ii) increase appropriations for Reimburse Owner Recovery Expense and Professional Services to reflect the FEMA NYS-DHSES check as follows:

- (i) \$ 3,018,034.49 increase revenue budget line ES.43960 (State Aid Emergency Disaster Asst.)
- (ii) \$ 9,054,103.46 increase revenue budget line ES.44960 (Fed. Aid Emergency Disaster Asst.)
- (iii) \$12,072,137.95 increase expense budget line ES8130.54899 (Reimburse Owner Recovery Expense)

AN ORDINANCE TO AMEND THE 2023 GENERAL FUND AND PARKS & RECREATION DEPARTMENT BUDGET TO FUND EMERGENCY REPAIRS AT THE PARKS & RECREATION MAINTENANCE GARAGE

WHEREAS, the Director of Parks & Recreation and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 General Fund and Parks & Recreation Department budget for emergency repairs at the Parks & Recreation Maintenance Garage in the amount of \$50,000.00; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on August 23, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 General Fund and Parks & Recreation budget in the amount of \$50,000.00 as follows:

A RESOLUTION AUTHORIZING THE MAYOR **ENTER** INTO SUPPLEMENTAL AGREEMENT NO. 3 WITH BARTON & D.P.C. LOGUIDICE, FOR ADDITIONAL SERVICES FOR PHASE 2 OF THE DECO DISTRICT STREETSCAPE IMPROVEMENTS **PROJECT**

WHEREAS, pursuant to Permanent Resolution 20-43, dated May 6, 2020, City Council authorized the Mayor to enter into an agreement with Barton & Loguidice, D.P.C. for preliminary design services for the DECO District Streetscape Improvements Project; and

WHEREAS, pursuant to Permanent Resolution 21-07, dated January 20, 2021, City Council authorized the Mayor to enter into Supplemental Agreement No. 1 with Barton & Loguidice, D.P.C. for additional services for the DECO District Streetscape Improvements Project; and

WHEREAS, pursuant to Permanent Resolution 22-30, dated April 6, 2022, City Council authorized the Mayor to enter into Supplemental Agreement No. 2 with Barton & Loguidice, D.P.C. for additional services for the DECO District Streetscape Improvements Project; and

WHEREAS, the City Engineer recommends the City enter into Supplemental Agreement No. 3 with Barton & Loguidice, D.P.C. for GIGP Grant Administration and Construction Phase Services for the DECO District Streetscape Improvements Project in an amount not to exceed \$257,350.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into Supplemental Agreement No. 3, approved as to form and content by the Office of Corporation Counsel, with Barton & Loguidice, D.P.C. for GIGP Grant Administration and Construction Phase Services, at a cost not to exceed \$257,350; and that funds shall be deducted from budget line H5112.525173.12220 (DECO District Improvements) for this purpose.

WHEREAS, the City of Binghamton is applying for the 2023-2024 Home Improvement Program Grant from the New York State Home and Community Renewal Affordable Housing Corporation in the amount of \$680,000; and

WHEREAS, the funds can be used to improve or rehabilitate housing units, limited to low to moderate-income owner-occupied households; and

WHEREAS, the Grant requires no City match; the grant funds will be reimbursable, and the Grant will be administered by the Director of Economic Development or his/her designee; and the estimated date of completion will be June 2028; and

WHEREAS, the funding contributes to ongoing community revitalization effort.

WHEREAS, the Manager, HUD Administration and Housing, recommends to accept \$250,000 in Revolving Loan funds from the Binghamton Local Development Corporation ("BLDC") as Community Development Block Grant ("CDBG") program income; and

WHEREAS, \$250,000 will be allocated in FY49 for economic activities for the Clinton Street Project.
