AN ORDINANCE TO AMEND THE 2023 BUDGET FOR EMERGENCY DEMOLITION OF A FIRE-DAMAGED PROPERTY AT 33 CHARLOTTE STREET

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 budget for demolition and air monitoring of a fire-damaged building at 33 Charlotte Street, Binghamton, New York, Tax Parcel No. 160.21-1-11, in the amount of \$17,900; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on August 23, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 budget for demolition and air monitoring of a fire-damaged building at 33 Charlotte Street in the amount of \$17,900 as follows:
  - (i) \$17,900 increase expense budget line M1910.54470 (Demolition)
  - (ii) \$17,900 increase revenue budget line M.42680 (Insurance Recoveries)

Section 2. That this Ordinance shall take effect immediately.
