ORDINANCE

AN ORDINANCE TO AMEND THE 2023 DEPARTMENT OF PUBLIC WORKS BUDGET FOR RESPONSIBILITY ADJUSTMENTS

WHEREAS, the Director of Personnel and Safety and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 Department of Public Works (DPW) budget to temporarily adjust the salary of the "Superintendent of City Streets" and "1st Deputy Commissioner"; and

WHEREAS, the position of the Commissioner of the DPW has become vacant due to a leave of absence from August 19, 2023 until November 25, 2023; and

WHEREAS, the "Superintendent of City Streets" was named "Acting Commissioner"; and

WHEREAS, the "1st Deputy Commissioner" is assuming additional responsibilities in support of the "Acting Commissioner" as well as some "Superintendent of City Streets" responsibilities; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on September 20, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 DPW budget to (i) temporarily increase the "Superintendent of City Streets" salary by \$7,264.05; (ii) temporarily increase the "1st Deputy Commissioner" salary by \$2,421.38; and (iii) to fund the increases to the "Superintendent of City Streets" and "1st Deputy Commissioner" positions from August 19, 2023 until November 25, 2023, paid as a responsibility adjustment as follows:
